The criterion applied to determine the winning offer will be implemented through the direct purchase procedure and will be the offer with the best quality / price ratio, of the following services:

Promotional services, CPV code 79342200-5, printing / imprinting of promotional materials for the following:

- Flyers - 20 pcs.
- Folders - 90 pcs.
- Imprinted pens - 90 pcs.

Printing services, CPV code 79810000-5, editing / publishing:

- The volume containing the works of an international conference - 200 pcs.
- A Good Practice Guide - 300 pcs.

The offer represents the firm commitment of the contract in accordance with related documents and will be developed according to the specifications book and the attached model.

The offer shall be submitted in one original exemplar. Each page of the offer must be stamped and signed. The offer is presented in a properly marked envelope and with the name and address of the bidder.

Please attach to the technical offer the following documents:

1. the financial offer form (Annex 1);
2. statement regarding the un-compliance with the situations referred to in art. 181 (Annex 2);
3. presentation sheet (Annex 3);
4. assuming the model contract (Annex 4);
5. ascertaining certificate released by the Trade Register or equivalent - in original, showing:
 - a) that the activity of the bidder includes the activities that are subject of the public procurement;



b) that there are no entries relating to bankruptcy or liquidation, business administration or by an insolvency of the opening of legal proceedings to be declared in one of these situations.

6. certificate of registration for individuals or businesses - released by the Ministry of Justice - Office of Trade Register or equivalent – a certified copy.

7. tax certificate released by the Ministry of Finance (in original), valid of the opening date of the offer, showing that the bidder has no debts to the state budget.

The envelope containing the offer will be sent / submitted at the Purchaser, in Timisoara, Dorobanților Street, no 4, Timis county. Submission can be made directly to the office by courier or by delegate.

The winning bid will be established on 14 September 2011 and announced on September 14, 2011. After the result of the selection is communicated, it can be contested by the bidders in two days from the communication date. The bidder contesting the result must submit the contestation at the Purchaser's headquarters. The Purchaser has the obligation of establishing an evaluation Committee and offer a written answer to the Objector.
